



Driving Instructor Verification Form

Customers who are unsuccessful on their first three (3) attempts at a Class 1, 2, 3, 4 or 5 road test must complete the Training Support Requirement (TSR). The TSR program requires a minimum of five (5) hours of documented driving instruction from an MPI-permitted driving school before the customer can make another road test attempt. Each subsequent road test after the third attempt will require an additional five (5) hours of documented driving instruction, following the same process.
