Manitoba Public Insurance may refuse to allow, or reverse any transaction that contained any false declaration, that was performed without legal authorization, or that did not meet the requirements to be validly completed. I declare on behalf of the carrier that:

- all information provided as part of any application for registration under the The Drivers and Vehicles Act and regulations (the "DVA") is true and complete, and understand that it is an offence under The Highway Traffic Act to knowingly provide false information or make a false declaration;
- I have legal authorization to perform the transactions on behalf of the carrier;
- any application is made in the carrier's full legal name (full name if different on file);
- Any vehicle that I add or remove from a carrier's fleet is eligible to be registered by the carrier because they are the owner of the vehicle with the exclusive right to use and pass property in the vehicle, or have the exclusive right to use the vehicle under a lease or other agreement for a period exceeding 30 days from the date of the application;
- the carrier satisfies the Manitoba residency requirements to apply for registration under the International Registration Plan as described here: www.irponline.org/page/theplan;
- the carrier will comply with the requirements of the DVA in respect of reporting changes of name, address, vehicle, and use of vehicle;
- the carrier is aware of and will comply with the limits imposed upon the use of vehicles registered as part of the International Registration Plan under the DVA;
- the carrier is aware of the insurance coverage restrictions that apply to Commercial Trucks operating for hire, or Commercial Trucks exceeding 11,794 kg GVW, which are operated 161 kilometers outside the border of the Province of Manitoba; and
- the carrier is aware that the vehicle registration shall be automatically suspended, without further notice, where payment for registration is dishonored.
